Students from Hong Kong, Macau, China, and overseas Chinese students enrolled in the university's standard liberal arts curriculum will be processed as international student standard curriculums

\*學系專業課程規劃 51 學分，學生應修滿主修學系專業課程至少 46 學分，不足部份，學生可以由管院他系自由選修，外系選修上限為 18 學分。

The professional courses of the department are 51 credits. Students should take at least 46 credits of the professional courses of the major. For the insufficient part, students may choose freely from all the other departments under AMC. The maximum number of electives from the other departments is 18 credits.

Due to the cost consideration, those who study management courses or with the same course name in other departments can be credited in the name of management or the same name courses.

If the courses of other departments are 2 semesters, that can be credited two similar single-semester courses.

More credits can be credited for less, but less credits can't be credited for more.

\*因開課人數考量，本系之法律課程名稱與他系課程名稱類似之非法律性質課程者，可相互抵免學分。他系同一門課程為上下學期者，可抵免本系單學期課程兩門。學分數可以多抵少，不可少抵用多。

Due to the cost consideration, the names of non-legal nature courses in other Management Departments are similar with the names of legal courses in Financial and Economic Law Department can be credited waiver and transference. If the courses of other departments are 2 semesters, that can be credited two similar single-semester courses. More credits can be credited for less, but less credits can't be credited waiver and transference for more.

The course title of "Electronic Commerce Law" and "International Technology and Law" can be credited waiver in the name of Commerce or Technology of other departments' courses.

Commercial law includes company law, negotiable instrument law, maritime law, and insurance law. It depends on the need of the students to conduct the topic of the course. Commercial law can be credited waiver for courses in the name of companies or enterprises of other departments.
